This confirmation email will be automatically produced so that the customer has confirmation of the purchase or booking of the service. If the service is not available, the customer will be informed by email or phone.

Dockerill's Entertainment may cancel any sale and not supply services if it is reasonable to do so and may change or discontinue availability of services at any time in her sole discretion. If an order is cancelled, any payment made for the products will be refunded in full. This does not affect your statutory rights.

## **PRICES**

Dockerill's Entertainment reserve the right to determine the price of the services. Dockerill's Entertainment will make reasonable efforts to keep pricing information on the website current. ## **PAYMENTS**

A receipt in the form of an e-mail shall be sent to the user. The receipt is the only proof of booking that the user shall receive. An invoice in respect of hire will be issued 4 weeks prior to the date of the event and FULL payment must be made no later than 2 weeks prior to the Hire date.

If the user fails to pay the invoice price by the date due then Dockerill's Entertainment has the right to cancel the booking with no deposit being returned to the user.

No refunds are to be given due to fault of the user in operation of, or use of, the Photo Booth,

Silent Disco, Display Board, British Post Boxes or in lack of obtaining, or in the refusal of the appropriate consents or permissions. No refund will be made for low usage of the facilities.

Your payment information will be treated and safeguarded with total security and with the exclusive purpose of processing the purchase of the services. Snags reserves the right to contract any payment platform available in the market, which treats your data for the exclusive purpose of processing the purchase of the services.

## **CANCELLATION / RETURN POLICY**

Upon receipt of written notification of cancellation four weeks prior to Hire date Dockerill's Entertainment shall refund any monies paid less the deposit. Upon receipt of written notification within four weeks prior to Hire date no refund will be provided.

Once your return is received and inspected, Dockerill's Entertainment will send you an email to notify you that we have received your returned item. We will also notify you of the approval or rejection of your refund.

If you are approved, then our customer support will let you know when your refund will be processed. Dockerill's Entertainment have the right charge the user for returning the post box late.

## **DAMAGE LOSS, INJURIES AND REPAIR**

The user must establish a deposit to cover the total value of the goods against any eventuality, loss, damage or theft. The value of the deposit will be determined according to the service and package purchased and booked.

According to these terms and conditions, users must return the goods in the same condition in which they are provided. If the problem is rectified the photo booth, Silent Disco, Display Board and British Post Boxes will be made available for use over the time provided, if the problem is a printer problem photos will still be taken and photos will be printed out the next working day and sent to the client. No Refund shall be given unless the Photo booth cannot take photos from a camera failure or hard drive failure.
